Research Project Title:

Children, Technology and Play

You are being invited to take part in a research project. Before you decide it is important for you to understand why the research is being done and what it will involve. Please take time to read the following information carefully and discuss it with others if you wish. Ask us if there is anything that is not clear or if you would like more information. Take time to decide whether or not you wish to take part. Thank you for reading this.

What is the project's purpose?

The aim of this study is to explore children's (aged 3-11) play and technology use. We would like to find out about the relationship between play, learning, creativity and technology, and to identify the skills and dispositions children develop through this use. We would also like to find out about how adults (parents/ teachers/ community members) interact with children during playful uses of technologies, and what their views are on play and technology.

Why has my family been chosen?

We invited parents in Sheffield to volunteer to participate in the research. You were one of the parents who volunteered. The final sample was selected by the research team, to ensure a balance in terms of the types of families and children involved.

Does my family have to take part?

It is up to you to decide whether or not to take part. If you do decide to take part you will be given this information sheet to keep (and be asked to sign a consent form) and you can still withdraw at any time without it affecting any benefits that you are entitled to in any way. You do not have to give a reason.

What will happen to my family if we take part?

You will be visited six times by a researcher. Each visit will last approximately 1-2 hours. During the visit, you (and/or another parent/ carer) will be asked questions about your child/children's uses of technology and media, and about their play. You will also be asked questions about your thoughts on your child/children's use of technologies, and their play. We will observe and film you and your child/children using technology in play. We will ask your child/children questions about their technology and about their play. We may ask your child/children to draw and/or take photographs/ films of her/ his technology use and play, and create a 'tech and play map' of the house. We will leave a Go Pro camera with your family and ask you/family members to record your child/children's play with technologies between researcher visits. We are also inviting parents to share videos and texts with researchers using the app WhatsApp, on a private group (so not accessible publicly).

What are the possible disadvantages and risks of taking part?

There are no risks associated with taking part. A potential disadvantage is the time you will devote to the visits from the researcher and the recording of play between researcher visits. Your child/children may also find wearing a Go Pro camera uncomfortable, but they will be reassured that they do not need to wear these if they do not wish to.

What are the possible benefits of taking part?

You and your child/children may enjoy sharing your views on play and technology. Participation in the project will enhance understanding of the relationship between play, learning and technology.

What happens if the research study stops earlier than expected?

If this happens, the reasons will be explained to you.

Will our part in this project be kept confidential?

All the information that we collect about your family and your child/children during the course of the research will be kept strictly confidential. You or your child/children's name(s) will be changed in any publications. However, because of the use of video recording and photographs, anonymity cannot be guaranteed unless you request us not to share the video and image data at conference presentations, or place in a data repository.

What is the legal basis for processing my/ my child/children's personal data?

According to data protection legislation, we are required to inform you that the legal basis we are applying in order to process your and/ or your child/children's personal data is that 'processing is necessary for the performance of a task carried out in the public interest' (Article 6(1)(e)). Further information can be found in the University's Privacy Notice <https://www.sheffield.ac.uk/govern/data-protection/privacy/general>.

As we will be collecting some data that is defined in the legislation as more sensitive (information about children's activities), we also need to let you know that we are applying the following condition in law: that the use of your data is 'necessary for scientific or historical research purposes.

Will we be recorded, and how will the recorded media be used?

You and your child/children will be recorded using a digital voice recorder. We will use a camcorder to film your child's use of technologies and play, and your participation in this. Your child may use a camera to record his or her use of technology and play. You may use a phone and/ or camera to share videos and data of your child between meetings. During the research project, the non-anonymised data recordings will be stored in a repository of the University of Sheffield, accessible only via a password. A transcript will be made of the audio interviews. The transcripts will be anonymised. The audio files will be destroyed at the end of the project.

The data will be analysed by the research team conducting this research at the University of Sheffield. The anonymised transcripts and image and video data that you have agreed to be shared will be accessible by the research teams at Dubit (www.dubitlimited.com/) and LEGO Foundation (www.legofoundation.com/en/).

With your agreement, the data we collect, including images and videos, may be used by the LEGO Foundation for websites, publications, conferences and workshops.

What will happen to the results of the research project?

The data collected will be stored in an encrypted University drive.

The University of Sheffield research team will have access to the data. They will treat the data confidentially. All audio data will be sent to a transcriber, who will treat the data confidentially. The transcribed data will then be anonymised. The anonymised transcripts and image and video data that you have agreed to be shared will be accessible by the research teams at Dubit and LEGO Foundation.

Due to the nature of this research it is very likely that other researchers may find the data collected to be useful in answering future research questions. We will ask for your explicit consent for your data to be shared in this way and, if you agree, the data will be stored in an open repository. Only anonymised data would be publically accessible; images and videos could only be accessed by special permission.

As outlined in the previous information sent to you, anonymised data will be used in publications, conference presentations, and on websites. It will not be possible to anonymise the image/ video data.
